OPEN MEETING: Council President Gerry Waller opened the regular meeting of the Donald City Council on Tuesday, December 10, 2024 at 6:45pm.

Manager Underwood asked the Council to write down their selection. Manager Underwood tallied the votes and announced the results as follows:

- o Three votes in favor of Councilor Waller serving as Council President.
- Four votes in favor of Councilor Olsen serving as Council President.
- One Councilor did not cast a vote.
- ✓ Councilor Coffman motioned, and Councilor Johnson seconded to appoint Jan Olsen as the Council President for 2025. No discussion. Vote: 6-0-1. Motion carried. Councilor Olsen abstained from voting.

✓ Councilor Waller motioned, and Councilor Coffman seconded to appoint City Manager Eric Underwood to serve as the Budget Officer. No discussion. Vote: 7-0-0. Motion carried.
