TREE ROOTS IN SEWER SYSTEM

Tree roots growing inside sewer septic tanks and pipes are generally the most expensive sewer maintenance item experienced by the City. Once inside the tank and/or pipe, a complete blockage will occur, if no action is taken to remove the roots. As roots continue to grow, they expand and exert considerable pressure at cracks or joints where they entered the system. The pipe becomes matted with grease, tissue paper, and other debris discharged from the properties. That is when the property owners will notice the first signs of a slow flowing drainage and sewer service backups will occur. The force exerted by the root growth will break the septic tank and pipes and may result in a total collapse of the infrastructure. Root intrusion that causes severe structural damage will require replacement.

Homeowners should be aware of the location of their sewer service and refrain from planting certain types of trees and hedges near the septic tank system. Before you start any property improvement, you should always check with the City to identify the utility's locations. The replacement cost of a sanitary sewer system, as a result of damage from tree roots, may be very expensive and the property owner is liable for any damage to the system.

BACKYARD BURNING

According to Oregon DEQ regulations, it is against the law to burn anything other than yard debris, clean and untreated lumber, paper and cardboard, or woody debris anywhere in the state. It is also illegal to burn materials that have been transported from another property. Fall open burning season: October 1st through December 15th. Burn season dates are subject to change without notice. Please call the Backyard Burn information line BEFORE you burn. To report outdoor burning on state-designated non-burn days or burning of illegal materials, contact DEQ.
